

#### CALL FOR INTERNATIONAL CHAIRS – SPRING 2015 AND FALL 2015

As part of its international relations policy, LUISS Guido Carli promotes the exchange of Faculty members with its relevant global partners. LUISS is accepting applications from internal units who would like to nominate **outstanding international scholars** and **researchers for up to 10 international chairs** at LUISS's Schools and in the departments of:

- Business and Management
- Economics and Finance
- Law
- Political Science

The purpose of this program is to enhance academic cooperation of the LUISS Faculty with international scholars, within the framework of partnership agreements with academic and research institutions around the world and especially with LUISS Guido Carli top partner universities.

This Call is subject to confirmation of funding for 2015.

## **Applicants**

**LUISS Professors, in accordance with their Departments/Schools of reference**, can apply for this Call. They will indicate their proposed partner university, and related MoU (Memorandum of Understanding) or agreement between LUISS and the partner university.

Applicants are the faculty members organizing the exchange. They are responsible for nominating an incoming international chair and an outgoing LUISS professor (applicants can nominate themselves as the outgoing professor, if they so choose).

Applicants must also provide the following information with regard to the prospective holder of the international chair:

- Name;
- CV;
- Activities: details of the teaching/research program;
- Period during which they would like to come to LUISS (SPRING semester 2015 or the FALL semester 2015);
- How long they would like to stay.

Prospective holders of international chairs are expected to stay from a minimum of **two weeks** to up to **four weeks** at LUISS, but longer visits can be arranged under special circumstances.

The Council for International Relations, chaired by LUISS's provost, conducts a competitive selection process to assign available positions. Preference is given to applications from LUISS's top partners and on the basis of reciprocity. Please note that for each partner university only one International Chair may be accepted.

With regard to reciprocity, the applicant will also need to provide the name, CV, period (in accordance with their departments/schools) and other information for the prospective LUISS faculty member going to the partner university.



The application should include all information about the proposed holder of the international chair and proposed LUISS faculty member going to the partner university. Moreover, it should specify the research/didactic activity to be carried out and provide the related funding formula, according to specific agreements with the partner university.

For the purposes of this Call, the following are considered to be LUISS faculty members:

- LUISS full professors;
- LUISS associate professors;
- LUISS researchers with teaching assignments

## Salary

International Chairs may be sponsored by the home institution or by the host institution.

The average salary from LUISS is as follows, depending on the *length of mobility*.

#### For **LUISS** professors:

- Junior: one-off payment of € 1000/€ 2000 (gross) issues in the usual wage through "compenso da maggior impegno sul ruolo" + a maximum of € 1000 as reimbursement\*;
- **Senior:** one-off payment of € 1500/€ 3000 (gross) issues in the usual wage through "compenso da maggior impegno sul ruolo" + a **maximum** of € 2000 as reimbursement\*.

#### For **incoming** professors:

- Junior: one single payment of maximum € 2,000/€ 3,000 (gross)\*;
- Senior: one single payment of maximum € 3,000/€ 5,000 (gross)\*.

The senior level requires a minimum of 8 years of post-doctoral experience, or at least 8 years of full-time research experience after earning a degree allowing admission to a doctorate. The junior level requires less than 8 years of post-doctoral experience, or a maximum of 8 years of full-time research experience after earning a degree allowing admission to a doctorate.

### **Visiting periods at LUISS**

- Spring 2015: Mid-February 2015 Mid-May 2015;
- Fall 2015: Mid-September 2015 Beginning of December 2015.

## **Important Dates**

- August 4, 2014: publication of the Call for applications;
- October 21, 2014: application deadline;
- November 2014: publication of selection results.

<sup>\*</sup> To receive the reimbursements professors must provide all the necessary proof of expenses, such as but not limited to: boarding pass and tickets receipts, hotel receipts, restaurant receipts, taxies etc.
