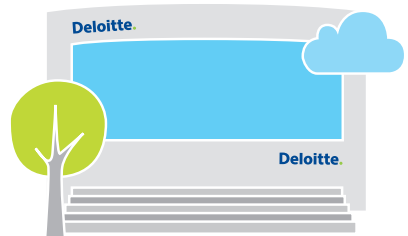

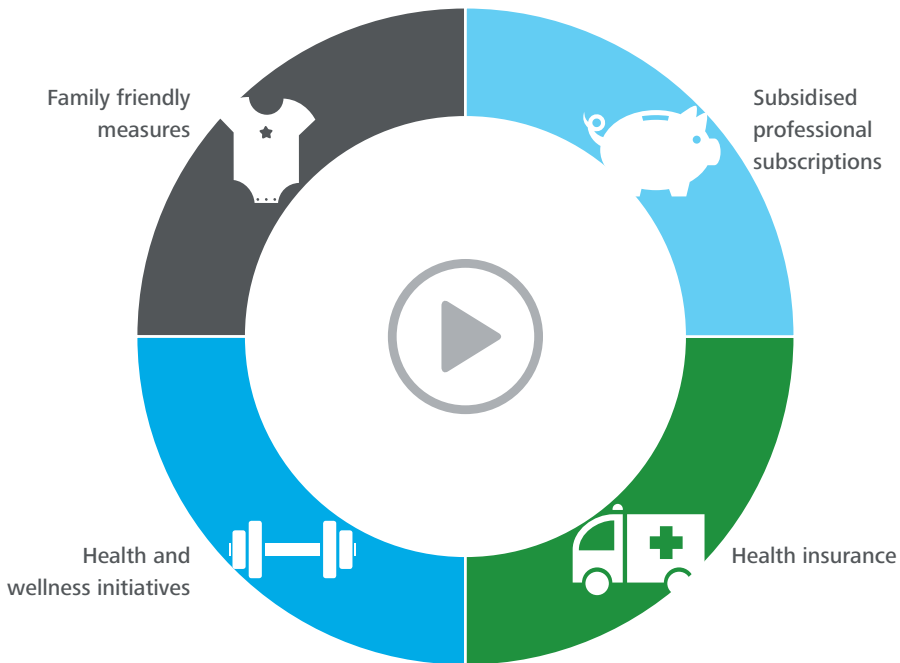

Good quality of life

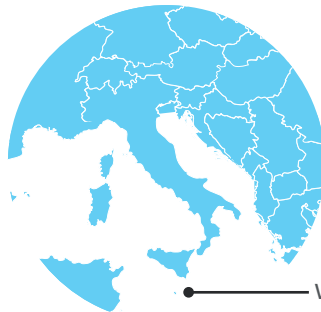
